- Local Government Reform Bill introduced to Northern Ireland Assembly in 2013
- NICVA's 2014 seminar with Community Places informed our members on the impact and workings of Community Planning.
- March 2015 Consultation on the Community Planning Guidelines launched NICVA held an event to assess the views of our members, before submitting our response to the Department.

# What is a Community Plan?

A Community Plan is a living document that:

- identifies local issues and opportunities
- sets out an achievable and long term vision for the future (15 years)
- prepares a plan of action (with indicators) to achieve this vision

Community Planning is not an end in itself!



# What's in a Community Plan?

Long term objectives for improving:

- Social wellbeing of a district;
- Economic wellbeing of a district; and
- Environmental wellbeing of a district;
- Identify long-term objectives in relation to the district for contributing to the achievement of sustainable development in NI; and
- Identify actions to be performed and functions to be exercised.

• A network of groups is defined as:

'a group of constituted organisations that have come together to form a network representing a wider body of

beneficiaries within their district electoral area'

#### **Nomination Form**

- Networks nominate an individual
- The network and individual complete the form together and both sign off
- Networks can nominate multiple individuals for different foras but there will be only one representative per fora from any one network



#### **Nomination Process**

- Nomination forms will be reviewed by a representative of Sector Matters along with Newry, Mourne and Down District Council representatives
- Successful nominees will be informed at the end of the nomination process



# **Ongoing Recruitment**

- Commitment to building capacity of organisations to form new networks of groups to nominate DEA fora members.
- DEA coordinators will assist with capacity building as requested
- Nominations for unfilled spaces on Fora part way through term will be accepted
